- a) We would like to confirm that no such negotiations were taking place with NBCC subsequent to submission of result on their earlier Resolution plan/offer submitted to National Company Law Appellate Tribunal in sealed cover on 02.07.2019 as their plan was rejected by the Creditor of Creditors.
- b) It is relevant to add here that NBCC has informed the Hon'ble Supreme Court yesterday that it is willing to takeover the responsibility of submitting a revised plan in Miscellaneous Application No.1122/2019 in Writ Petition (C) NO.744/2017 of Chitra Sharma and Hon'ble Supreme Court has allowed the NBCC to submit the revised plan and adjourned the matter to 17th October, 2019. A copy of the Order of Supreme Court (which is self explanatory) is enclosed.

O R D E R

Counsel for the N.B.C.C. (India) Limited has appeared pursuant to the notice issued on  $3^{\rm rd}$  September, 2019.

I.R.P.

He submits that N.B.C.C. (India) Limited is willing to take over the responsibility of preparing a revised plan so as to address the issues of all aspirants/stakeholders.

The concerned aspirants/stakeholders are free to make written representation(s) to N.B.C.C. (India) Limited not later than one week from today, so that their concerns can be taken note of by the N.B.C.C.(India) Limited whilst formalizing the revised Plan.

The N.B.C.C. (India) Limited after finalization of the revised plan may have to place it before the appropriate authority for its due consideration. That may require at least three weeks time. We accede to this request. The salient features of the proposed revised plan so finalized be produced in a sealed cover to the Court for its perusal on the next date of hearing.

In view of the above, we defer the hearing of these matters for four weeks with a hope that the appropriate authority may be in a position to take a final decision before the next date.

List these matters on 17<sup>th</sup> October, 2019.

Needless to observe that this shall be without prejudice to the rights and contentions available to the parties.

Interim arrangement to continue till the next date of hearing.
